#### OBJECTIVES .

The basic objective of this FDP is to expose the participants to various time series models and analyzing the data. This course also provides an understanding of the algorithms behind each of these models and their applicability based on the type of data.

- Unit Root and their testing (ADF Test, PP Test)
- Univariate return modelling AR, MA and ARMA models
- Identifying and testing AR, MA and ARMA models
- Univariate volatility modelling (ARCH, GARCH, EGARCH, GJR- GARCH models)
- Cointegration meaning, test
- Multivariate return modelling VAR and VECM
- Multivariate volatility modelling EWMA, BEKK
- Dynamic Time series modelling TVP VAR, DCC GARCH

#### PEDAGOGY

The teaching methodology will be through discussions and supplemented by hands-on applications on real time data. The entire course will be conducted in Python. There will be 4 sessions every day each of 1.5 hours. Participants will carry out a mini project of analyzing any financial data and the presentation will be made by the participants on the last day, last session of the FDP.
